 - TRAVIS APGAR PRESENT
 - OPEN FORUM LAST WEEK ON ALCOHOL
 - 3RD PARTY VENDORS
 - IT IS DIFFICULT TO GET THE VENDORS OFF PREMISE BECAUSE OF PERMITS
 - THE VENDORS ARE MORE LIKELY TO WANT HOUSES TO COME TO THEIR PREMISES
 - APGAR
 - ◆ RENSSELAER BEING THE VIA FOR THE VENDORS
 - ◆ IT STILL IS SOMETHING THAT NEEDS TO BE EXPLORED FURTHER
 - ◆ IT MAY BE AN OPTION THAT COSTS HOUSES AS LITTLE AS NOTHING
 - SOBER RIDE FOR EVERY PERSON
 - MORE DIRECT CONTROL OVER PEOPLE COMING TO THE PARTY
 - HOUSES WOULD DRIVE ONLY THEIR BROTHERS TO PARTIES
 - HOUSE THROWING THE PARTY DRIVES INDEPENDENTS

- MAKES IT SO THAT HOUSES CAN TAKE CARE OF THEMSELVES BETTER
 - REDUCES PROBLEMS WITH NEIGHBORHOOD PARKING
 - INSURANCE/LIABILITY ISSUES OF SOBER DRIVERS
 - APGAR
 - ◆ WORTH LOOKING INTO ADDITIONAL RIDERS ON INSURANCE POLICIES TO COVER ADDITIONAL EVENTS
 - PARTY ADVISOR
 - PRESIDENT OF ANOTHER HOUSE
 - WHEN ONE HOUSE THROWS A PARTY, IT IS A LIABILITY TO THE WHOLE GREEK SYSTEM
 - WORKING AS AN EXTRA SET OF EYES TO HELP OUT OTHER HOUSES
 - SHOULD THE ADVISOR HAVE LIABILITY?
 - APGAR
 - ◆ BELIEVES IT TO BE A GOOD IDEA
 - ◆ WOULD MAKE IT TWO PEOPLE RATHER THAN ONE
 - ◆ PROVIDE SOME SORT OF TRAINING
 - ◆ IF THERE ARE NO CONSEQUENCES WILL THEY BE HELPFUL?
 - E-BOARD FEELS YES
 - ◆ STILL ON THE FENCE ON THE LIABILITY ISSUE
 - PARTY PLANNING SEMINAR
 - PRESENTED BY LARGER, ESTABLISHED HOUSES
 - HELP TO PROMOTE RESPONSIBILITY IN DEVELOPING HOUSES
 - REVAMPING OF POLICIES ARE INEVITABLE
 - APGAR

 - ◆ AS LONG AS THEY ARE SAYING THE CORRECT THINGS
 - ALCOHOL SEMINAR
